Some activity recommendations that were mentioned today for Goal 1 were:

- Creating policy where no vape shops are allowed within a certain radius around schools
- Put together a trifold/ brochure of information related to vaping and smoking that can be placed in various places in the community, to provide education to community members
- Create an online voluntary survey that can be used in the community and/or schools to measure whether smoking rates are going down or not.
- Want to do more assemblies at schools related to smoking/vaping prevention/ cessation.
