CALL TO ORDER

Boise County Commissioner Steven Twilegar called the Public Health District 4 (PHD4) Budget Committee meeting to order at 10:00 a.m.

III. CHANGES TO THE AGENDA

IV. NEW BUSINESS

1. Vote on minutes from May 21, 2021 Public Health District 4 Budget Committee Meeting

Motion: Betty Ann Nettleton moved to approve the minutes for May 21, 2021 Public Health District 4 Budget Committee meeting as presented. Seconded by Commission Elt Hasbrouck. No further discussion. By voice vote, Commission Elt Hasbrouck, Betty Ann Nettleton, and Commissioner Rod Beck voted yes. Motion carried unanimously.

2. Discussion and Vote on the proposed FY-2023 Central District Health Budget

Per Idaho Code 39-423, the PHD4 Budget Committee considered Central District Health's proposed fiscal year 2023 budget, including a request for a 3% increase from the counties to begin July 1, 2022. Commissioner Twilegar asked for a motion to approve the proposed FY-2023 budget as presented to the four County Boards of Commissioners in District 4 after reviewing the expenditures in the budget.

Motion: Commissioner Elt Hasbrouck made the motion to approve the proposed CDH FY-2023 budget as presented to begin July 1, 2022. Seconded by Betty Ann Nettleton. Ada County Commissioner Rod Beck stated that the budget includes APRA funds that have not been approved yet and are subject to change. APRA is like any other contract that may change during the year. It was noted that actual county contributions would not change when approved. By voice vote, Commission Elt Hasbrouck, Betty Ann

Nettleton, Commissioner Rod Beck, and Commissioner Steven Twilegar voted yes. Motion carried unanimously.
