Presenter: Judge Ellis

The Panel hosted Judge Andrew Ellis, who handles all family cases in Ada County, for a question-and-answer session to get his feedback on the current state of the foster system in the area, and in Idaho as a whole. The session transcript is in a separate file, which is also posted. The Panel wished to note the following items in the minutes that Judge Ellis listed as the changes he would make, were he given a proverbial magic wand to change the foster care situation in Idaho.

- Be able to put every family with a child in the system in a house and solve housing instability.
- Triple the number of foster homes in the state so kids can get into a home with a family.
- Double the number of social workers and reduce their case load by half.

Meeting Scheduling

Due to scheduling conflicts some of the Panel Members were going to have going forward, the Panel chose to shift their meeting dates starting in February to the second Monday of the month.

New Member Status Update

The new Panel Members are still pending background checks results due to problems the State is experiencing with the background check system.
