### **III. NEW BUSINESS**

1. Vote on minutes from May 20, 2022 Public Health District 4 Budget Committee Meeting by Al Hofer, Elmore County Commissioner and Budget Committee Chair

**Motion:** Commissioner Elt Hasbrouck moved to approve the minutes for May 20, 2022 Public Health District 4 Budget Committee meeting as presented with the correction of Commissioner Rod Beck's name. Seconded by Commissioner Rod Beck. There was no further discussion. By voice vote, Commissioner Al Hofer, Commissioner Rod Beck, Commissioner Clay Tucker, and Commissioner Elt Hasbrouck voted yes. 2. Discussion and Vote on the proposed FY-2024 Central District Health Budget by Al Hofer, Elmore County Commissioner and Budget Committee Chair

**Motion:** Commissioner Elt Hasbrouck made the motion to approve the proposed Central District Health FY-2024 budget as presented to begin July 1, 2023. Seconded by Commissioner Clay Tucker. By voice vote, Commissioner Al Hofer, Commissioner Rod Beck, Commissioner Clay Tucker, and Commissioner Elt Hasbrouck voted yes. Motion carried unanimously.
