Meeting Minutes

Overdose data overview *by Mark Babson, Ada County Paramedics*

The data showed what the primary and secondary reasons for calls for service that were responded to when they were related to overdoses. He shared some of the tools they have to drill down into the data. Ideas were shared for ways to enhance the data set that is gathered.

ODMAP overview and updates *by Karyn Kershaw, Overdose Response Strategy*

Karyn shared ODMAP, which shows the location of where overdoses happen. She discussed where data is pulled from, and what information is being displayed. ODMAP is designed to not trigger HIPAA protection, so privacy is maintained. Karyn discussed how to enter data and what credentials are required to have that access.
