Meeting Minutes

Call meeting to order and roll call *by Courtney Boyce, Public Health Lead*

Courtney Boyce, temporary Public Health Lead, called the Central District Health (CDH) Drug Overdose Prevention Program (DOPP) Public Health and Safety Team (PHAST) meeting to order at 11:03 a.m. The PHAST members were identified by roll call: Mark Babson, Ada County Paramedics; Kurt Freeman, Boise Fire Dept; J.D. Hendrick, Meridian Fire Dept; Nicholas Kulack, Meridian Police Dept; Danielle Fanopoulos, North Point Recovery; David Steece, The ROC; Amber LaRocco, Trivium Life Services; Kendall Nagy and Hailey Blogg, Meridian Anti-Drug Coalition; Courtney Boyce, Central District Health.

Vote to approve of agenda *by Courtney Boyce, Public Health Lead*

Courtney asked the PHAST to approve the agenda as presented.

Motion: Ayes Mark Babson motioned to approve the agenda as presented. Seconded by J.D. Hendrick. No further discussion. Motion carried unanimously.

Vote to approve of minutes *by Courtney Boyce, Public Health Lead*

Courtney asked to approve the September meeting minutes as presented.

Motion: Ayes J.D. Hendrick motioned to approve the minutes as presented. Seconded by Amber LaRocco. No further discussion. Motion carried unanimously.

CDH Resource Support for First Responders *by Courtney Boyce, Public Health Lead*

Courtney shared several resources that may be appropriate for first responders, such as a vehicle-based overdose rescue kit, wall-mounting and pole-mounting waterproof naloxone dispensing storage box, insulated bags for naloxone leave-behind initiatives, and the naloxone distribution box. The group discussed what current solutions are in place from the Meridian Police Department, Boise Police Department, and Ada County Sheriff's Office. Resource support may be needed from organizations like Parks and Recreation, volunteers for Parks and Recreation on the Greenbelt, Mobile Response Teams, Idaho State Troopers at the Capitol mall area, and non-emergency Medicaid transportation services.

Interventions Used Inventory *by Courtney Boyce, Public Health Lead*

Courtney opened up and described the 'Inventory of Evidence-based Interventions' template. The group went through the template and discussed how Trivium Life Services provides harm reduction services, law enforcement diversion, and training on 9-1-1 Good Samaritan Laws through their naloxone trainings. We discussed the populations served, geographic reach, what gaps/needs or challenge does each intervention meet, evidence of success, limitations and barriers and partners or facilitators. At the next meeting we will complete the template and hope to have support from recovery programs and folks representing the justice-involved populations. We ran out of time so 'Member Input and questions' on the agenda, was tabled.
