# Update on Idaho City City Council LEAP Housing Meeting (Mindy)

Bart Cochran with LEAP Housing, and Mindy went to present to Idaho City City Council on November 13<sup>th</sup>. The presentation was similar to the July meeting that happened, but the goal was to get the blessing from city council to move forward with conversations. They were supportive of the continuation of the conversations for Idaho City, however, we need to first discuss, and figure out what infrastructure needs will be, and make sure whatever we propose or move forward with will not add a burden to the current water and sewer struggles that the city is working through. The next community meeting will likely happen in January or February, where we will start taking steps to identify sites.

The question was asked if these affordable housing conversations are limited to Idaho City. Conversations could expand to Horseshoe Bend or Garden Valley, if there is interest and community support for it. It sounds like water and sewer infrastructure is going to be a concern in other communities as well.

#### Mobile Pharmacy/ Prescription Delivery Updates (Mindy)

Mindy followed up on some questions regarding certain types of medications, and their ability to be mailed to patients. Rosemary, from Garden Valley Medicine, provided some very useful insight about how dispensing at their clinic happens for their patients. They do have a dispensing license, but only dispense certain medications for their patients. She said, typically if people are going down to the valley to see their provider, they are picking up their meds down there as well. There was also conversation about Amazon delivery for prescriptions, which sounds like is available in Boise County.

Tonya mentioned the struggle for Idaho City being that there is no provider in Idaho City. If there could be a hospital taxing district implemented, it could help bring providers to the area. As for the old clinic area in the school building in Idaho City, the clinic portion is being unused, except for WIC, who uses is one Tuesday every other month. However, it was mentioned, that is it not very

accessible to the people that need it. Tonya mentioned talking to Russ, director of CDH, to send a provider to Idaho City on a regular basis.

Rosemary mentioned having issues recruiting a nurse practitioner or physicians assistant for their medical clinics as well. Mindy is going to help promote the job in her circles. <u>Here</u> is the link to the Garden Valley Medical Clinic job listing, for coalition members to share in their circles as well.

# Present Mental Health Fair Plan (Mindy)

Mindy proposed an idea to try and stand up some "mental health fairs" in the different Boise County communities. The idea was that we bring in vendors to offer free mental health, self care and/or coping services at their booths, and also bring in mental health organizations to do outreach to folks who might like to sign up for mental health services. We are also thinking we want to offer booth spaces to local businesses first, before bringing in vendors from the valley. There is funding available from a number of different avenues, but we need to decide what the money would be spent on, and come up with a plan before applying. Perhaps provide a stipend for local businesses who offer services at the event?

Travis from the Boise VA was interested in doing outreach. It is also essential to have food at the event! Idaho Youth Ranch does mental health services and telehealth for youth, Laura will send Mindy the contact for them. We also talked about not labeling it a "mental health fair". For example, Horseshoe Bend did a health fair called "Healthy in Horseshoe Bend". We could get creative and think of some other ideas for the other communities.
