<u>Update on Idaho City LEAP Housing Taskforce (Mindy)</u>

Mindy sent out a survey to get availability from Idaho City community leaders to find out when would be a good time to schedule a next meeting, but have only gotten 2 responses thus far. Tonya recommended starting conversations in other Boise County communities and Kelsey mentioned she is confident they could get this conversation started pretty easily in HSB. Mindy will reach out to Bart at LEAP and ask about the possibility of making a pitch to HSB City Council.

Mindy shared brainstormed name ideas for the events in the different city. Still need to work on finding one that fits well for Idaho City. We also brainstormed other important details for the events, e.g.:

- Choose a date(s) in Sept. to align with back to school, cooler outdoor temps, and suicide prevention month.
- Make sure to check school schedules and align with them.
- Try to piggyback GV/HSB in AM/PM so vendors can plan for one whole day rather than multiple trips?
- Have a passport/BINGO card for participation at booths.

It sounds like we don't want to provide funding to vendors for participations, but could use funding for buying food for the event (if possible in the funding guidelines) OR food gift certificates OR baskets for a free raffle.

Ideally there would be a committee of people working on this in each community. Laura does most of the planning for the HSB event, but we may be able to work all together. Mindy will be in contact with everyone interested/able to help plan on a regular basis (check ins via email once a month). We can also provide updates and ask for help at future coalition meetings.

Wee Ones last day open before Christmas break is Friday Dec 20^{th,} but will be available for emergent needs over the Christmas break until Jan 10th. They have lots of diapers and wipes if anyone needs help with those resources. Laura is going to email and connect with Tonya about their shared clientele. Laura also mentioned there are emergent food services available from the HSB Food Pantry.
