Old Business

Updates on primary care providers, if any (Mindy)

Mindy reached out again to Idaho Outreach Medicine (Dori Healy) to continue the conversation about coming up to Boise County to provide primary care to residents. She is still open to doing care in Boise County, and Mindy is working on getting marketing materials from her. It is going to be very important for whoever the provider is to be consistent and advertise well. They could come when Tonya is doing WIC clinics every other month. Make sure to promote on Nextdoor, Facebook, Idaho world, posters, etc.

Updates on housing conversations, if any (Mindy)

Mindy has been working on getting info from LEAP about housing conversations that might be happening, but haven't heard anything back yet. Mindy also sent along a grant opportunity to the Idaho City clerk, but hasn't heard about whether they were interested or not. Tonya mentioned sending it along to Nancy who writes the grants for Parks and Rec, or to her to pass along to city council. Idaho City is dealing with a major water leak, and have been shutting off water randomly throughout the day. Not much more to update here.

Updates on home health care, if any (Mindy)

Mindy has been trying to reach out to home health care agencies, inquiring if they would be able to serve Boise County or not. But it appears most bigger agencies with the most likely capacity are corporate and really hard to get a hold of. Tonya mentioned reaching out to Trinity Home Health, as they have been advertising up there.

Community Health Fair Follow Up (All)

Idaho City- Mindy filled out the form to book the Community Hall for October 4th for the Community Health Resource Fair. Working on getting the rental fee waived or getting it paid for.

Garden Valley- Waiting on the Garden Valley School District to set their calendar. Leaning toward trying to do something in the fall, when all the locals re-engage. Open to doing something the same date as a Chamber Event to get more involvement, but also open to hosting our own thing.

Horseshoe Bend- Mindy working with Laura to find out a solidified date for Horseshoe Bend. Potential Date: Sept 6th, waiting for confirmation on that.

Mindy has been reaching out to regional or statewide orgs for availability to serve Boise County, and their interest or availability to attend a health fair whenever we get those scheduled. The response has been good so far, with a good number of orgs interested in participating, once we know the dates!

New Business: Roundtable Announcements, Needs and Ideas

Stephany: Charlie Health is putting together MOU with GV school district. Stephany reported: Charlie Health is for most severe needs students, 9-week program, kids seen 3x per week for 3 hour sessions, ages 13+. Sessions could happen at home as well. GV School is building out 3 soundproof spaces for telehealth to occur. Charlie Health is billing individuals' insurance. Still looking for services for moderate need students and below 13: Stephany reaching out to BPA.

**Barrier to telehealth at school is to have staff available to set up tech and have a person there to help problem solve.

Toyna's next WIC clinic in Idaho City is on May 20th! Mindy- Shoutout to Tonya who helped Mindy get a Cooking Matters class started and going in Idaho City! Seven participants showed up the first class! The class is being held at the library and will be held for 6 weeks. We hope the families have a good time, learn healthy eating and cooking skills! Mindy is going to share info about Cooking Matters with Stephany, who may be interested in the curriculum to use in Garden Valley. Tonya mentioned Eat Smart Idaho, also does cooking classes through the University of Idaho, and they used to do classes with PAT families in their homes, but also host them at the extension office in Garden City. Tonya is going to connect Mindy to her contact there Mindy- Gentle reminder that the 2026 Community Health Needs Assessment is live.
