Call Public Health District 4 Budget Committee meeting to order – Comr. Rod Beck, Chair of Budget Committee

Motion: Comr. Clay Tucker motioned to approve the proposed Central District Health Fiscal Year 2026 Budget as presented to begin July 1, 2025, seconded by Comr. Katlin Caldwell. The motion was put to a vote and carried unanimously.


Adjournment – Comr. Rod Beck, Chair of Budget Committee
